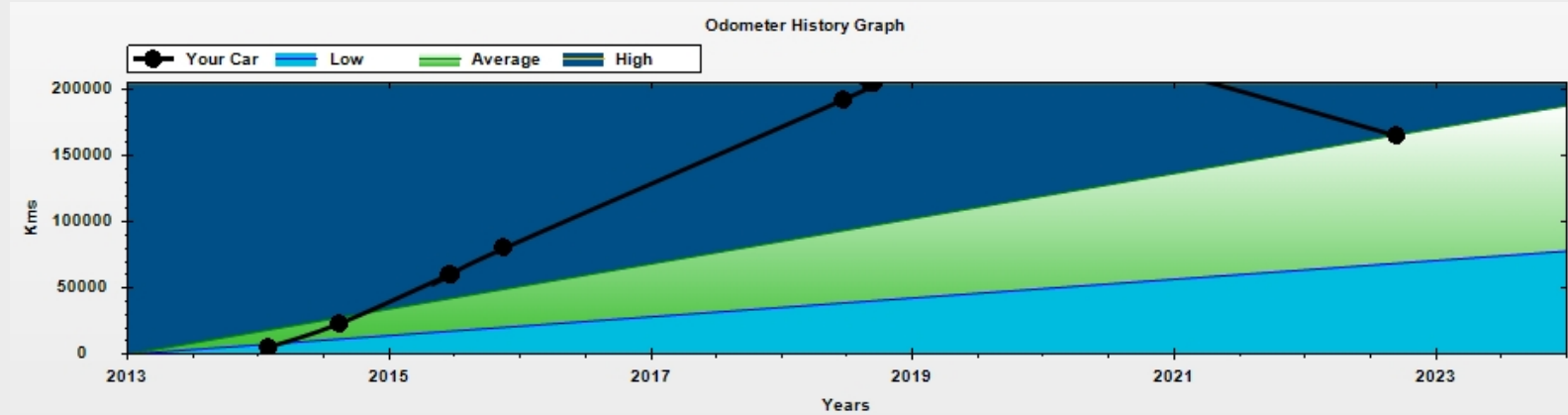

The score is a star rating, between 1 to 5 stars. The higher scores are awarded more stars. |
| Body | A vehicle's body type. |
| Cylinders/Rotors | Engine cylinder configuration. |
| Dealer Price | An indicative vehicle value for non-franchise dealer trade or wholesale transactions. Trade low must be adjusted for (Back 10 Years) kilometres and condition. Please refer to the 'Guide Condition' definition. |
